ACTION PLAN:

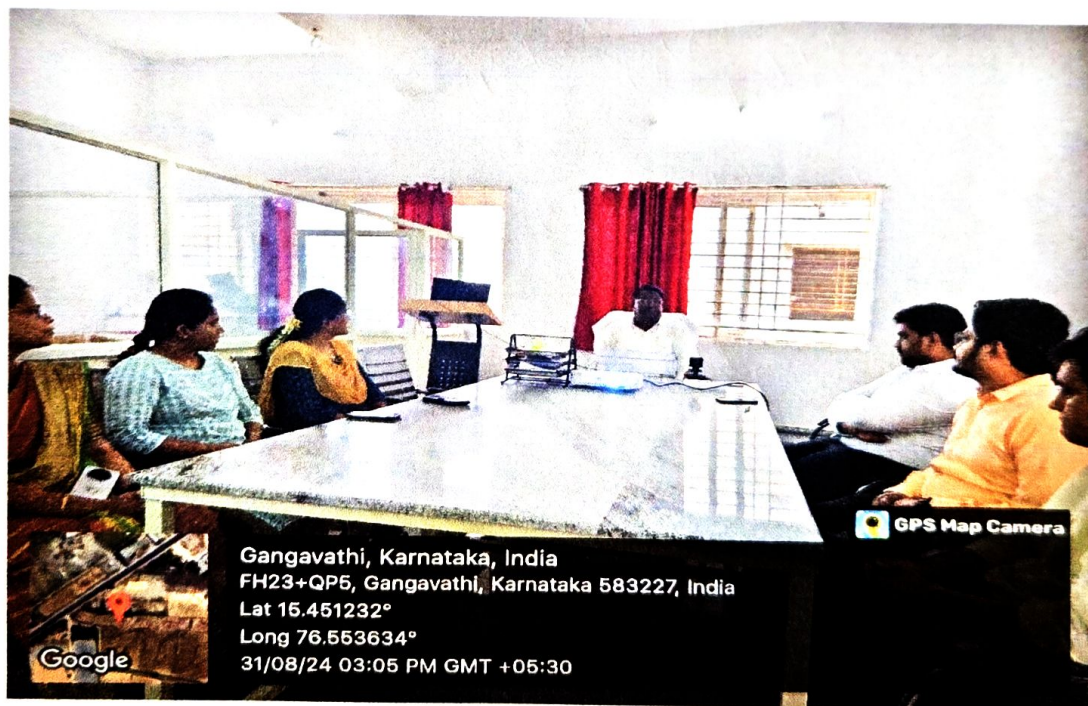

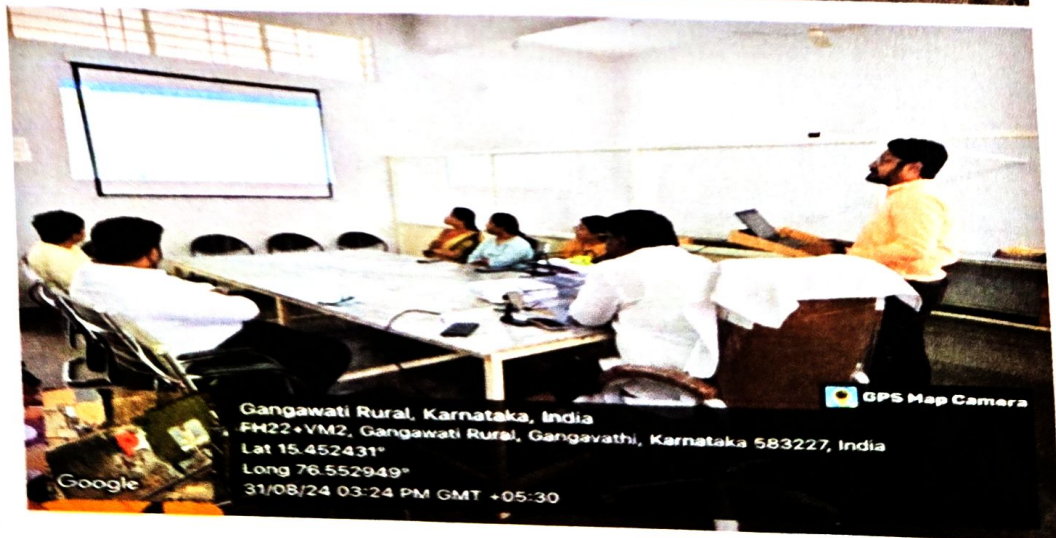
